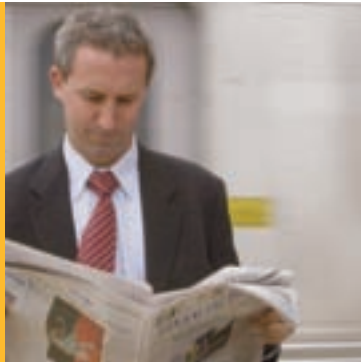

Real time cross border trading and settlement capability provided by GBST Shares™ enables your business to provide a full service to your clients in any market they wish to trade, domestic or foreign.

Manage your clients' global financial needs

Shares™ will process securities listed on offshore markets, or dual listed securities on domestic and off shore markets, settle the cash for these trades in any nominated currency and maintain records of foreign scrip holdings: i.e. buy in one currency, sell in another and settle in a third. A single entry automatically generates and posts the client contract and the trade with the offshore

counterparty. The system dynamically maintains client positions in multiple currencies and multiple markets (supporting the rules and coding schemes applicable to each local market) and manages foreign currency conversions, accounting for profit and loss and commissions. Custody arrangements with off shore custodians are also supported on behalf of clients.

With offices in US, Canada, Europe, Australia, Hong Kong, and Israel, ITG is a listed broker-dealer on the NYSE and a leader in advanced equity trading technologies. International clearing – reduce regional processing costs

Shares™ supports processing on a regional basis (i.e. a system integrated with multiple exchanges and clearing houses). The capability will support a single broker operating in multiple markets but clearing

through a central system, and service providers offering offshore trading, clearing and settlement services to local brokers. Consolidated processing via a central “hub” reduces costs and allows you to manage exposure and risk across a number of markets in real time.

Turning Real Time into Real Money

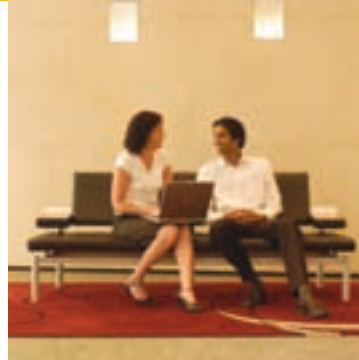

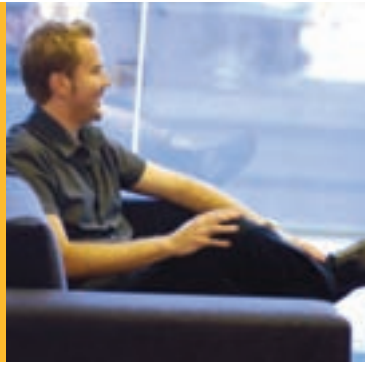
